

Memorandum of Understanding (MoU)

Preamble:

This Memorandum of Understanding (MoU) is entered into by and between Government Degree College, Rayachoti, hereinafter referred to as "GDCR," and R.R Associates, Rayachoti, hereinafter referred to as "R.R Associates."

- 1. Short-term and Long-term Internships:

The specific number of internships, duration, and requirements shall be decided upon through separate agreements as per the requirements of each internship program.

GDCR faculty members may be involved in providing guidance and academic oversight to ensure that the internship programs align with GDCR's curriculum and educational goals, with a particular focus on GST, accounting, auditing, income tax e-filing, and chartered accountant-related activities.

4. Responsibilities:

The responsibilities and expectations of each party will be detailed in separate internship agreements for each GDCR student participating in the programs, including specific tasks related to GST, accounting, auditing, income tax, and chartered accountant-related activities.

5. Duration:

-This MoU shall become effective on the date of signing and will remain in force for a period of three years, unless either party wishes to terminate or modify the agreement with prior written notice.

6. Governing Law:
